

Maggie's and Open House London Night Hike **Friday 19th September 2008**

Terms and Conditions

This event is being organised on behalf of The Maggie Keswick Jencks Cancer Caring Centres Trust a company limited by guarantee (Company number SC162451) and having its Registered Office at 20 Castle Street, Edinburgh, EH1 2ET ('Maggie's') (registered as a charity in Scotland with number SC024414). By registering yourself / your team to take part in Maggie's & Open House London Night Hike 2008 (the 'Event') you are agreeing to the following conditions of entry:

- Adult Hikers must be at least 17 years of age to participate, whilst Child Hikers (16 years or under) by 19th September 2008 must be accompanied by a participating adult.
- You must pay a non-refundable registration fee of £37.50 per adult, £150 per challenge team (4-6 members) and £25 per child participant, when submitting this form. No place is secured until this fee is received and on the occasion that the Event is full we will refund your registration fee.
- All adults should commit to raising a minimum sponsorship requirement of £300 per person and teams should aim to raise £1,200 between them.
- You must send any sponsorship money, which you have raised to Maggie's as soon as possible, attached to a collected funds form, which is available at www.maggiescentres.org/nighthike or nighthike@maggiescentres.org.
- Fundraising deadline for all monies is 19th November 2008.
- If for any reason you or a team member choose not to take up your place / are not permitted to take part in the event / the event is cancelled, all sponsorship forms and money collected must be forwarded to Maggie's and will not be refunded.
- Maggie's has no responsibility to ensure that you are fit for the Event; you must all ensure that you have the appropriate level of fitness to take part. You must all confirm that, to the best of your knowledge, you are currently in a good state of health and that you will not take part in the Event unless you are in a good state of health at the time. If you have any health concerns at any time about taking part, you should speak to your doctor.
- Any hiker over 65 years of age at the time of the Event must provide Maggie's with a letter from their GP stating that they are fit to take part in the Event.
- You / your team are all taking part in the Event at your own risk. Neither Maggie's nor the organisers will have any responsibility for any risk, loss or costs which you incur in connection with the Event and you will indemnify Maggie's, the organisers and any persons acting on their behalf for any risk, damages, loss or costs arising as a result of your participation in the Event.
- Neither Maggie's nor the organisers will carry insurance in relation to your participation in the Event so it is your responsibility to obtain any necessary insurance in connection with the Event.
- You / your team will all comply with Maggie's guidelines when raising fundraising for the Event. Details of these guidelines are available on request.
- You must all provide Maggie's, the organisers and any persons acting on their behalf with information, which they may request in connection with the Event. Any photographs taken at the event and given to Maggie's will be usable by Maggie's in future publicity materials.
- Prior to and during the event you / your team will be responsible for your own safety, you will take reasonable care to ensure the safety of other participants and you will comply promptly with all instructions and guidelines given by Maggie's, the organisers and any persons acting on their behalf.
- You / your team accept that the interests and reputation of Maggie's are of paramount importance. Maggie's may at any time and at its sole discretion, cancel the Event, change the published venues, withdraw your place on the Event or exclude you from the Event.
